

COOKIE NOTICE OF LIMEADE, INC.

This Cookie Notice applies to Limeade, Inc. (“Limeade” or “we”) and our websites at www.limeade.com and <https://go.limeade.com/limeade-engage> (together, the “Websites”). This Cookie Notice explains how we use cookies and similar technologies to recognize you when you visit our Websites, why we use them and rights to control our use of them.

WHAT ARE COOKIES?

Cookies are small text files that are sent to or accessed from your web browser or your computer's hard drive. A cookie typically contains the name of the domain (internet location) from which the cookie originated, the “lifetime” of the cookie (i.e., when it expires) and a randomly generated unique number or similar identifier. A cookie also may contain information about your computer, such as user settings, browsing history and activities conducted while using our Websites. Cookies are widely used by website owners to make their websites work or to work more efficiently, as well as to provide analytics data about the operation of their websites.

Cookies set by the website owner (in this case, Limeade) are called first-party cookies. Cookies set by any other party are called third-party cookies. Third-party cookies enable third-party features or functionality on or through our Websites, such as interactive content and analytics. The parties that set third-party cookies can recognize your computer both when it visits our Websites and also when it visits certain other websites.

WHY DOES LIMEADE USE COOKIES?

We use first-party cookies and third-party cookies for several reasons. Some cookies are required for technical reasons for our Websites to operate - we refer to these as "essential" or "strictly necessary" cookies. Other cookies enable us to track and target the interests of our visitors to enhance the experience on our Websites.

The types of cookies served through our Websites and the purposes they perform are described below:

- “Strictly necessary” cookies must be set to allow us to deliver our Websites to you and to provide specific services that you request from us.
- “Performance” or “Analytics” cookies, which help us to collect information about how visitors use our Websites and helps us analyze and improve our Websites. Performance or analytics cookies will remain on your computer after you close your browser.
- “Advertising” cookies are used to make advertising messages more relevant to you. They perform functions like preventing the same ad from continuously reappearing, ensuring that ads are properly displayed for advertisers, and selecting advertisements that are based on your interests.

DOES LIMEADE USE OTHER TRACKING TECHNOLOGIES, LIKE WEB BEACONS?

Cookies are not the only way to recognize or track visitors to a website. We may use other data collection technologies from time to time, like web beacons (sometimes called "tracking pixels" or "clear gifs"). A web beacon is computer code that contains a unique identifier that enables us to monitor user activity and traffic on our Websites. This other data collection technology enables Limeade to monitor the traffic patterns of visitors from one page on our Websites to another, to deliver or communicate with cookies, to understand whether you have come to our Websites from an online advertisement displayed on a third-party website, to improve performance of our Websites and to measure the success of our email marketing campaigns.
